

# END USER TRIAL LICENSE TERMS & CONDITIONS

Last updated on March 17th, 2023

AxonIQ B.V., a Dutch corporation having its registered office at Lange Viestraat 2b, 3511 BK Utrecht, The Netherlands (“AXONIQ”) is willing to grant you as the company or the legal entity that will use this trial license (“LICENSEE”) the right to access and use its software AxonIQ Server Enterprise Edition (the “Software”) if You agree to these End User Trial License Terms & Conditions (“Agreement”). If You wish to use the Software on behalf or for the benefit of your employer, by accepting this License You do so on Your own behalf as well as that of Your employer, and You warrant and represent that You have authority to do so. You acknowledge that You have read this Agreement, understand it, and agree to be bound by it. If You do not agree to any of the terms below, AXONIQ is unwilling to license the Software to You, You are not authorized to download or use it for any purpose.

## 1. Definitions

- 1.1 “Affiliate” means, with respect to a party, any entity that controls, is controlled by, or which is under common control with, such party, where “control” means ownership of at least 50% of the outstanding voting shares of the entity.
- 1.2 “Agreement” means these end user trial license terms and conditions together with the Annexes, if any.
- 1.3 “AXONIQ” means AxonIQ B.V. and its Affiliates.
- 1.4 “Capacity” means a specific licensed size criteria as mutually agreed in writing by AXONIQ and LICENSEE and may include, among other measurements, events-per-second per cluster counts, running application counts.
- 1.5 “Documentation” means the user guides and manuals for the installation and use of the Software, provided in electronic form.
- 1.6 “Free Licenses” means licenses which are offered on a free of charge basis, such as a trial license, a proof of concept version of a license or a beta license.
- 1.7 “License Key” means a component of the Software that enables one or more components of the Software (for example, authorization keys) to operate within the Capacity. Certain components of the Software may be licensed hereunder without a License Key.
- 1.8 “LICENSEE” means the legal entity as indicated expressly to AXONIQ in writing that rightfully acquires the Software, License Key or Free Licenses from AXONIQ.
- 1.9 “Replaced License” means a License Key that has been replaced or superseded by another License Key for the

purpose of direct substitution.

- 1.10 “Software” means the computer software programs in object code (machine-readable) form only for which LICENSEE is granted a license hereunder, the Documentation therefore and Updates thereto.
- 1.11 “Software Schedule” means the specific information regarding the licensed Software, Capacity, name of LICENSEE, term and system applications for which the Software is licensed for use, mutually agreed in writing by AXONIQ and LICENSEE.
- 1.12 “Node” is an instance of the AxonServer process that is connected to other Nodes to form a Cluster and is classified as either “Production,” “Pre-Production” or “Development.” - “Production” means use for any purpose other than the purposes specified below for Pre-Production and Development. An instance running in standby mode also classifies as a Production Node. “Pre-Production” means use solely for QA, staging, end-user testing or other non-development pre-production purposes. “Development” means use solely by developers testing code or use solely in a sandbox environment that is not accessed or in any way used by users of the production system. Development usage of Axon Server and Axon Data protection is part of all AXONIQ subscriptions without any additional cost. Free Licenses are permitted to be used for Development only.

## 2. Software License

### 2.1 Grant of License and Limitations.

- 2.1.1 Subscription. Subject to the terms and conditions of this Agreement, AXONIQ grants LICENSEE during the applicable term and for the restricted scope of this Agreement a personal, non-transferable, non-exclusive, limited license to use the Software.
- 2.1.2 Capacity. The Capacity limit for the Software under this Agreement, may be enforced by the Software itself where appropriate. In this case, the Software may deny further requests that would exceed the Capacity and will in that case issue an appropriate error message as logging. Some agreed Capacity limits may not be enforced by the Software at all. Regardless of any enforcement mechanism, the LICENSEE is responsible for operating the software within the Capacity limits.
- 2.1.3 Scope. The license is restricted to the organisation of LICENSEE and includes use for its Affiliates. In case of divestment of any Affiliate the license automatically ends.
- 2.1.4 License Key. AXONIQ will deliver to LICENSEE a License Key that enables LICENSEE to use the applicable Software in accordance with the rights granted in this section 2 of this Agreement. The Software is deemed to have been delivered to LICENSEE upon provision of such License Key and the Software is deemed accepted by LICENSEE upon delivery.
- 2.1.5 Open source software. The Software may contain or be provided with open source software, as identified in the Documentation. Notwithstanding anything to the contrary herein, use of the open source software shall be subject to the license terms and conditions applicable to such open source software. AXONIQ makes no warranties, express or implied with respect to any open source software. To the extent the terms of open source licenses applicable to such open source software

prohibit any of the restrictions in this Agreement, such restrictions will not apply to such open source software.

The Software Documentation includes an overview including references to the licenses applicable to the Open-Source Components.

To the extent the terms of the licenses applicable to open source software require AXONIQ to make an offer to provide source code in connection with the open source software, such offer is hereby made, and LICENSEE may exercise it by contacting [support@axoniq.io](mailto:support@axoniq.io).

## 2.2 License Restrictions.

2.2.1 Copy Restrictions. Copyright laws and international treaties protect the Software, including the Documentation. Unauthorized copying of the Software, the Documentation or any part thereof, is expressly prohibited. Subject to these restrictions, LICENSEE may make a reasonable number of copies of the Software and Documentation to the extent necessary for the authorized use by LICENSEE of the Software. All titles, trademarks, and copyright and restricted rights notices will be reproduced in such copies.

2.2.2 Use Restrictions. This Agreement only gives LICENSEE some rights to use the Software and AXONIQ reserves all other rights. LICENSEE does not acquire any rights, express or implied, other than those expressly granted in this Agreement. Unless applicable law gives LICENSEE more rights despite this limitation, LICENSEE may use the Software only as expressly permitted in this Agreement. In doing so, LICENSEE agrees that it will comply with any technical limitations in the Software that only allow LICENSEE to use the Software in certain ways. LICENSEE agrees that it will not, nor will LICENSEE permit others to:

- (i) reverse engineer, decompile, disassemble, modify, adapt or translate the Software or any component thereof (including Documentation), or create derivative works based on the Software (including Documentation), except and only to the extent that applicable law expressly permits, despite this limitation or except and only to the extent that AXONIQ gives it prior written consent;
- (ii) remove, obliterate, destroy, minimize, block or modify any logos, trademarks, copyright, digital watermarks, or other notices of AXONIQ or its licensors that are included in the Software;
- (iii) work around any technical limitations in the Software or hack the license enforcement mechanism and /or circumvent the limitations on use of the Software that are imposed or preserved by any License Key;
- (iv) make more copies of the Software than as allowed in this Agreement or allowed by applicable law, despite this limitation;
- (v) publish the Software, including any application programming interfaces included in the Software, for others to copy; or,

(vi) transfer, sublicense, rent, lease, sell, lend or assign the Software or any part thereof, or any rights or duties under this Agreement, to any other person or entity without the prior written consent of AXONIQ and such consent may be withheld in the sole discretion of AXONIQ.

2.2.3 High-Risk Use. Unless AXONIQ gives its prior written consent and is consulted regarding the specific deployment, system set-up and Software support plan, LICENSEE has no right to use (and must not use) the Software in any application or situation where the failure of the Software could lead to death or serious bodily injury of any person, or to severe physical or environmental damage (“High Risk Use”). High Risk Use does not include utilization of the Software for administrative purposes, to store configuration data, engineering and/or configuration tools, or other applications, the failure of which would not result in death, personal injury, or severe physical or environmental damage. LICENSEE agrees to indemnify and hold harmless AXONIQ from any third-party claim arising out of LICENSEE’s use of the Software in connection with any High-Risk Use.

2.2.4 Replaced License Key Restrictions. License Keys may be replaced for various purposes. A Replaced License Key must be removed from any device and its original license file must be destroyed or archived and clearly marked as “Inactivated” so that it cannot be used. The act of replacement includes but is not limited to:

- (i) Upgrades – when an earlier or lower numbered version license is replaced by a newer or higher numbered version license;
- (ii) Functional Upgrades – when a license with certain Capacity and functionality is replaced by a license with greater Capacity or different functionality;
- (iii) Lost/Stolen/Failed Keys – when a License Key is lost, stolen, or fails and a replacement License Key is provided. If a lost/stolen License Key is found/recovered, it must be destroyed; or,
- (iv) Keyed License to Keyless License.

2.3 Free Licenses are provided “AS IS” with no warranty of any kind, to the extent permitted by law, and AXONIQ is under no obligation to provide any Support Services or maintenance. LICENSEE assumes all risks and all costs associated with the use of such Free Licenses. LICENSEE’s sole remedy with respect to Free Licenses is termination of the use of the Free Licenses. Any obligations of AXONIQ to indemnify, defend or hold harmless under this License do not apply to Free Licenses.

2.4 AXONIQ retains all title, copyright and other proprietary rights in, and ownership of, the Software regardless of the media upon which the original or any copy may be recorded or fixed. The Software is licensed, not sold.

### **3. Verification/Audit**

At AXONIQ’s written request, not more frequently than annually, LICENSEE will furnish AXONIQ with a signed certification verifying that the Software is being used in accordance with the provisions of this Agreement. AXONIQ may audit LICENSEE’s use of the Software. Any such audit will be conducted during regular business hours at LICENSEE’s facilities and will not unreasonably interfere with LICENSEE’s business activities. If an audit reveals that

LICENSEE is using Software contrary to the terms and conditions of this Agreement then LICENSEE will be invoiced for additional license fees consistent with LICENSEE's actual use of the Software in accordance with AXONIQ's then current price list for the Software, which amount will be immediately due and payable. This assessment of additional fees will be without prejudice to any other remedies AXONIQ may have for breach of this Agreement, including without limitation, termination under Section 5 ("Term and Termination").

## **4. Liability Limitations**

- 4.1 NOTWITHSTANDING ANY PROVISION OF THIS AGREEMENT TO THE CONTRARY, IN NO EVENT WILL AXONIQ, NOR ANYONE ELSE WHO HAS BEEN INVOLVED IN THE CREATION, PRODUCTION OR DELIVERY OF THE SOFTWARE, INCLUDING AXONIQ LICENSORS, BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, PUNITIVE OR CONSEQUENTIAL DAMAGES, OR DAMAGES FOR LOSS OF PROFITS, BUSINESS, GOODWILL, REVENUE, DATA OR USE, INCURRED BY LICENSEE OR ANY THIRD PARTY, WHETHER IN AN ACTION IN CONTRACT OR TORT, EVEN IF AXONIQ HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
- 4.2 NOTWITHSTANDING ANYTHING TO THE CONTRARY IN THIS AGREEMENT, AXONIQ'S LIABILITY FOR DAMAGES AND EXPENSES HEREUNDER OR RELATING HERETO (WHETHER IN AN ACTION IN CONTRACT, TORT OR OTHERWISE OR WHETHER RELATED TO PARTICULAR SOFTWARE OR SOFTWARE SUPPORT SERVICES) WILL IN NO EVENT EXCEED THE AMOUNT OF ONE HUNDRED EURO. LICENSEE ACKNOWLEDGES THAT AXONIQ'S PRICING REFLECTS THE ALLOCATION OF RISKS, OWNERSHIP OF INTELLECTUAL PROPERTY RIGHTS AND THE LIMITATION OF LIABILITY HEREUNDER.
- 4.3 THE LIMITATIONS SET OUT IN THIS SECTION DO NOT APPLY IN CASE THE DAMAGE IS CAUSED BY THE WILLFUL INTENT OF GROSS NEGLIGENCE ON THE PART OF THE MANAGEMENT OF AXONIQ.

## **5. Term and Termination**

- 5.1 Term. This Agreement shall commence on the date your trial license to the Software was confirmed by AxonIQ for the duration specified with the confirmation. At the end of the initial term the Agreement will automatically terminate without further notice being required. The Agreement will not automatically renew. Any renewal is subject to an explicit agreement by the parties to this effect.
- 5.2 Termination. AXONIQ and LICENSEE shall each have the right to terminate the Agreement immediately upon written notice in the event the other party materially breaches the Agreement and such breach is not cured within seven days after written notice of such breach. Either party may also terminate the Agreement immediately if the other party (a) terminates or suspends its business; (b) becomes subject to any bankruptcy or insolvency proceeding; (c) becomes insolvent or subject to direct control by a trustee, receiver or similar authority, or (d) has been wound up or liquidated.
- 5.3 Effect of Termination. Upon termination of this Agreement or the license granted hereunder, LICENSEE will cease using the Software and Confidential Information, will delete the Software, including the License Keys, from its computers and will either return to AXONIQ or destroy the Software, including the License Keys,

Documentation, and all copies thereof. If LICENSEE elects to destroy the Software then LICENSEE will certify in writing within thirty (30) days after termination to AXONIQ the destruction of the Software.

## **6. Export Restrictions**

LICENSEE agrees to comply fully with all applicable international and national export laws and regulations, including the U.S Export Administration Regulations and the Office of Foreign Asset Control Regulations, as well as end-use and destination restrictions issued by the U.S and foreign governments to assure that neither the Software nor any direct product thereof are (i) exported, directly or indirectly, in violation of export laws; or (ii) are intended to be used for any purposes prohibited by the export laws.

## **7. Governing Law and Dispute Resolution**

This Agreement will be governed by and construed in accordance with the laws of the Netherlands, excluding the U.N. Convention on Contracts for the International Sale of Goods. All disputes, claims or controversies arising out of or relating to this Agreement that are not resolved by the parties' good faith attempt to negotiate a resolution will be submitted to the exclusive jurisdiction of the courts in Amsterdam, the Netherlands.
